AN ORDINANCE REGULATING THE USE AND SIZE OF STALL (PAPAG) OF THE TRANSIENT VENDORS AT THE LIGAO CITY PUBLIC MARKET

EXPLANATORY NOTE

It has been observed that transient vendors and stall owners are utilizing extended stalls (papag) and not the authorized and standard measurement in the City Public Market.

To effect orderliness and uniformity of stalls (papag) within the City Public Market of Ligao City, the Committee on Economic Enterprise of the Sangguniang Panlungsod is hereby enacting this ordinance in accordance with Section 458 (ii) of RA 7160 otherwise known as the Local Government Code of 1991.

Be it ordained by the Sangguniang Panlungsod in session assembled that;

ARTICLE 1
TITLE

THIS ORDINANCE SHALL BE KNOWN AS THE TRANSIENT VENDOR AND STALL (PAPAG) REGULATION ORDINANCE OF 2011.

ARTICLE 2
DEFINITION OF TERMS

- a.) **TRANSIENT VENDORS** – shall refer to any person or individual, resident or non-resident of the City of Ligao, who sells or vends or is employed to attend or watch goods in behalf of the vendor or seller in the dry goods or vegetable sections in the City Public Market.
- b.) **STALL HOLDER** – one who manages a stall at which articles are sold.
- c.) **CAMARIN** – it is an area or place in the public market wherein local transient vendors display their wares or goods be it wet or dry goods for sale.

ARTICLE 3
PROVISIONS

SECTION I – It is hereby ordered by the Sangguniang Panlungsod thru the Committee on Economic Enterprise to effect cleanliness, orderliness and sanitation at the Ligao City Public Market.

SECTION II – TIME ALLOTMENT - Transient vendors shall be allowed to sell their goods or wares only during the schedule stated herein.

MORNING – 6:00 am to 12:00 noon
AFTERNOON - 4:00 pm to 6:00 pm

SECTION III – MEASUREMENT AND SIZES OF STALLS OR PAPAG-

FOR DRY GOODS SECTION – 1X 2.5 Meters
FOR VEGETABLE SECTION – 1X 2 Meters

SECTION IV – IMPLEMENTING RULES AND REGULATIONS OF THIS ORDINANCE

- a.) The market personnel headed by the Acting Market Administrator is tasked to strictly enforce this ordinance.
- b.) Violators shall be dealt with accordingly.
- c.) In case of necessity assistance from the PNP personnel is hereby recommended.

SECTION V – PENALTY PROVISION – Violators of this ordinance particularly Sections II and III shall be penalized as follows:

- 1st Offense – WARNING
- 2nd Offense – CONFISCATION OF STALL OR PAPAG
- 3rd Offense – CONFISCATION OF STALL OR PAPAG TOGETHER WITH ITS GOODS OR WARES.

SECTION VI – REPEALING CLAUSE - All ordinances or resolutions in conflict with this ordinance is hereby repealed or amended.

SECTION VII – EFFECTIVITY - This Ordinance shall take effect upon publication in a local newspaper.




