ORDINANCE NO. 2011-012

AN ORDINANCE APPROVING THE REVISED RATES OF 2011 PLANTILLA POSITIONS AND AUTHORIZING THE RELEASE OF THE CORRESPONDING FUNDING REQUIREMENT PURSUANT TO E.O. 900 IMPLEMENTED UNDER LBC 95 FOR THE 2nd TRANCHE SALARY SCHEDULE FOR LGU PERSONNEL EFFECTIVE JANUARY 1, 2011 AMOUNTING TO SIX MILLION FIVE HUNDRED FIFTY FIVE THOUSAND (PH 6,555,000.00) TO BE TAKEN FROM THE LUMP SUM APPROPRIATION UNDER THE SPECIAL PURPOSE FUND OF THE 2011 ANNUAL EXECUTIVE BUDGET.

EXPLANATORY NOTE

Pursuant to Executive Order 900 was issued on June 23, 2010, to implement the second tranche of the modified Salary Schedule for civilian personnel among others, under Senate and House of Representatives Joint Resolution No. 4. s. 2009, approved on June 17, 2009, which was implemented thru LBC Circular No. 95 dated June 29, 2010 (Implementation of the Second Tranche Monthly Salary Schedule for Local Government Personnel). Accordingly, the Chief Executive wrote a letter dated June 27, 2011 addressed to the Honorable Vice-Mayor and the Members of the Sangguniang Panlungsod indorsing the revised plantilla of personnel for 2011 and requesting thereat the release of funding requirements of the corresponding increase of salaries of LGU personnel to be taken from the lump sum appropriations under special purpose fund as reflected in the 2011 Annual Executive. Such increase is retroactive effective January 1, 2011.

SECTION 1 – It is hereby ordered to approve the revised rates of 2011 plantilla positions and authorizing the release of the corresponding funding requirement pursuant to E.O 900 implemented under LBC 95 for the second tranche salary schedule for LGU personnel effective January 1, 2011 amounting to **SIX MILLION FIVE HUNDRED FIFTY FIVE THOUSAND (PH 6,555,000.00)** to be taken from the lump sum appropriation under special purpose fund of the 2011 Annual Executive Budget, as follows;

SECTION 2- Provision - Section 4 of E.O. No. 900 provides the following : .

SECTION 4. Implementation of the Second Tranche Monthly Salary Schedule for LGU Personnel. – The implementation of the Second Tranche of the modified Salary Schedule for LGU personnel shall be determined by the Sanggunian, on the basis of the LGU income class and financial capability: Provided, That such salary rates shall not exceed the applicable percentages of the salary rates in Annex “A” pursuant to item (7) (a) of Joint Resolution No. 4: Provided, Further, That the resulting Personnel Services (PS) cost shall not exceed the PS limitation in LGU budgets, as provided under Sections 325 (a) and 331 (b) of R.A. 7160 : Provided, Finally, That there shall be no diminution in the basic salaries of incumbents for purposes of complying with the said PS limitation.

Furthermore, the revise rates for the 2nd tranche salary schedule was based on a 4th Class City in this LBC 95.

SECTION 3- Provision- SECTION 7.2 of LBC No. 92 - states that Incumbent personnel whose positions are among those which are re-allocated with changes in salary grades as listed in Annex “B” shall receive the salaries in the applicable salary schedules in item 6.1 or 6.3 of this circular which correspond to the same steps as those in the previous salary grade allocations of their positions , provided they meet the civil service qualification standard on education, training, experience and RA No. 1080 eligibility for the re-allocated position.

Librarian 1-SG 10 to SG 11

Item No. 30, Librarian I, under the Office of the Mayor, whose salary grade was upgraded from SG 10 to SG 11 under the 1st Tranche Salary Schedule per LBC Cir. No.92 dated 9/03/2009 cannot be effected and is now being rectified in this revised plantilla of personnel to retain Librarian I from SG 11 back to SG 10 due to deficiency of eligibility requirement of the employee occupying such position.

SECTION 5 – EFFECTIVITY – This Ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Albay.


SECTION 6 – DATE ENACTED – June 27, 2011.
