**AN ORDINANCE APPROVING THE REALIGNMENT OF SOME MOOE ITEM IN THE APPROPRIATION OF THE SANGGUNIANG PANLUNGSOD IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FROM TRAVELLING ALLOWANCE-FOREIGN TO TRAINING EXPENSES**

**EXPLANATORY NOTE**

Pursuant to Sec. 336 of R.A. 7160 -USE OF APPROPRIATED FUNDS AND SAVINGS- Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the Local Chief Executive or the presiding officer of the Sanggunian concerned may, by ORDINANCE, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within same expense class of their respective appropriations.
